Listed below are active Benicia Chamber of Commerce committees that encourage participation from our members and their employees. - AMBASSADORS** – Serving as the public relations arm, Ambassadors assist with a variety of Chamber functions including special events, ribbon cuttings, monthly mixers, and community events. Ambassadors play a significant role in fundraising for the Chamber. The Committee offers an opportunity to meet new people, promote your business and network. Call Chamber staff for more information or to schedule an orientation. Ambassadors meet the 2nd Tuesday of each month, 8AM, at the Chamber office.
- BENICIA INDUSTRIAL PARK ASSOCIATION (BIPA)** – A committee of the Chamber, membership in BIPA shall be limited to one person from each firm or business located or having interests* in the Benicia Industrial Park *(i.e., building ownership, management, development and/or leasing). Applications for membership shall be **subject to the approval of the Board of Trustees**. Each applicant, upon payment of BIPA and Chamber annual dues, shall become a member of both the BIPA and the Chamber. Trustees meet the third Wednesday of the month, 7:30AM, at the Chamber office.
- BIZNET** – A networking committee, this group of highly motivated and committed business people network to increase the success of each members business through education, support and referrals. Each member represents an exclusive business category within the committee (a wait list is available if your category is currently taken). Members provide business updates and share viable leads. Members meet every Thursday, 7:30AM, at the Chamber office.
- BUSINESS ADVOCACY COMMITTEE** – Members serve as a research and advisory committee for the Benicia Chamber of Commerce Board of Directors. Its primary purpose is to meet with elected officials and city staff, review and monitor legislative matters that may impact local business, present recommendations to the Board, and assist in the initiation of the appropriate action. The Business Advocacy Committee (BAC) meets the 4th Tuesday of each month, 8AM, at the Chamber office.
- SOUTHAMPTON MERCHANTS** – Merchants meet to identify and address needs in the Southampton Shopping Center, including tenant matters, improvements, and promotional/marketing activities. The committee setting provides an opportunity for the merchants to communicate and network on a regular basis. Southampton merchants meet the 3rd Tuesday of each month, 8:30AM, at Round Table Pizza.
